I represent Harmeny Athletics Club who lease the Saughton Athletics Enclosure twice a week. We would like to know the following information:

- 1. The most recent annual operating costs and income for Saughton Sports Centre. This should be broken down, wherever possible, to show separately for operating both the centre as a whole and the cost of operating the Enclosure.
- 2. The information should include, but not be restricted to:
 - Employee costs with details of number of employees and hours worked
 - Pitch management
 - Any security associated with the enclosure
 - Property/land Rental or Tax costs
 - Maintenance costs, broken down to show those specifically within the enclosure
 - Utilities, again broken down to show costs attributed to the enclosure, including the electricity costs for running floodlights
 - Any subsidies provided by COEC or anyone else
 - Income from football and income from athletics specifically related to the hire of the enclosure
