Request

I recently wrote to the Scottish FA regarding the publication of participation figures published on their social media platforms.

A section of their reply is extracted below (in red):

We note that a significant number of participants, 31,709 are attributed to community clubs, partners and stakeholders, almost 20% of the headline figure of 161,421. Can you expand on this group and provide examples of the clubs or organisations referred to i.e. name the clubs or teams.

The development of the sport has resulted in more players wanting less formal access to the game. Not everyone wants to play for a team. We have looked at different ways to ensure we can register these players for reporting, monitoring and evaluation purposes.

Stakeholders such as Local Authorities, Leisure Trusts and Club Charities deliver a wide range of weekly football activity (which we support) which players particate in. As those stakeholders are not affiliated to an ANA, we register those players directly.

Can Edinburgh Leisure please advise of the number of football players (grassroots i.e. not paid/professionals) they have registered directly with the Scottish FA as suggested above in the calendar year 2024?
