- Any staff training or guidance related to preventing sexual offences.

I would appreciate all data from 2020 up until 2025 to be included, separated into calendar years where possible. I understand that data identifying individuals cannot be shared. Where possible, please provide data related to swimming and bathing activities e.g. in swimming pools or bathing facilities or changing areas for people who use these. If you do not have this level of data and only have data for the broader leisure centre, then please provide this.
