# Question 1: EL has previously said that it would cost around 2k to open the toilets at Portobello Swim Centre. Could I please ask how this was worked out?

#### Withheld under Section 17 Information Not Held

Edinburgh Leisure does not hold the information requested.

We have completed our searches for information relating to the toilets at Portobello Swim Centre. There are no returns specific to the cost to provide public access. It has been discussed, however not recorded, and the costs were estimated and related to additional staffing (cleaning and managing access). All those directly involved have left EL.

We can however provide the following information from discussions:

Because of the layout of Portobello i.e. 2 entrance doors and the toilets being located upstairs and the opening hours we would need more than 1 person. The venue requires staff to control access and staff upstairs to supervise use / clean the toilets.

The  $\pounds 2k$  was based on an estimated requirement of circa 160 hours per week at  $\pounds 9.50$  per hour plus on costs (rate when calculated in 2021).

 $\pounds$ 9.50 per hour was our 2021 rate. Based on £12 per hour, the weekly cost would increase to £2750 per week. And after April this could increase to anything between £2830-£2930 per week.

Edinburgh Leisure does not hold the information requested as the question is asking about a future intention (and is subject to many further discussions, negotiations and formal processes that are yet to happen), as such it is not held information.

There has been verbal discussion about our desire to pay RLW - but no formal minutes. We don't start formal discussion until our Board meeting (which this year is in March) - which will be subject to funding confirmation from City of Edinburgh Council in late February. There is no written note of our intention this year.

We have reviewed the Board papers for February 2024 - relating to the 2024/25 pay award. There is a section in there (copied below), that covers the approach

From Board report (B agenda, so not in public domain) in February 2024:

The Board are aware of the dialogue that has taken place in various Council forums regarding EL and the RLW and the message that has been emphasised throughout these discussions is we (EL) want to pay the RLW but require additional funding from CEC in order to do so. The proposed increase in our funding, which includes the £2.2M to enable us to pay the Real Living Wage, will be considered as part of the Council's 2024/-25 budget deliberations on 22nd February, and we should have a decision by the time of the Board meeting.

It may be beneficial contacting Jen Holland our Chief Executive or Karen Scott our Head of People directly and having private dialogue about that question.
