Unfortunately, we are unable to provide you with the information requested in question 4 above as it is not held by Edinburgh Leisure.

There has been no correspondence with Scottish Golf regarding winter course layout.

Edinburgh Leisure Golf Club & Silverknowes G.C have never approached us regarding setting a winter course / stroke index up.

As far as I am aware you need to have set distance markers (Permanent Measured Teeing areas) to determine lengths of holes. As we have no winter set teeing areas and use areas on the fairways which can vary greatly in length, we cannot have a set measured course. All our courses have some very wet areas which sometimes means we must close some holes, move tee markers halfway up fairways or open a composite course with a mixture of holes. Any pre-set course would not be able to be used for handicapping or competition purposes.

There are a total of 2147 unique Direct Debit (DD) members that paid for a Golf membership DD in March 2025.

The usage figures are from April 2024 until 13th March 2024.

Out of 2147 members 2090 members had used at least one of our Golf sites during the time period, while the rest had no usage.

Out of 2090 members that used, 577 members had used only 1 site

Following are the sites and number of members that used only that site:
